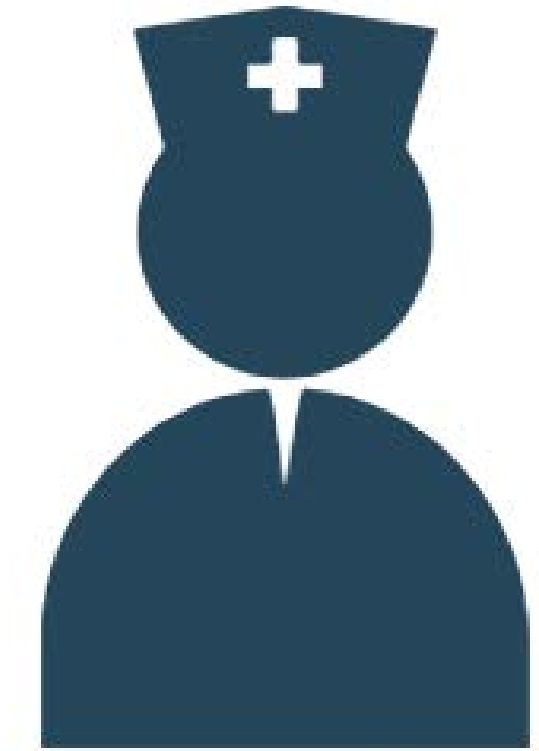

Appointments are conducted at your loved one's facility. This allows them to feel at ease and benefit most from their visit. Family members are welcome to join in person or by video.

If needed or requested, a facility staff member assists as a Telehealth Coordinator during your loved one's appointment.

The Telehealth Coordinator serves as an intermediary and is available to answer questions and help manage the technical aspects.

Appointments are conducted on a weekly or monthly schedule, depending on your family member's needs.

- Recently lost a loved one?
- Been taking, or has recently been prescribed, anti-psychotic medications?

SHOWN SIGNS OF DEPRESSION SUCH AS:

- Lack of appetite?
- Feeling tired or hopeless?
- Lack of interest in daily activities?

SHOWN SIGNS OF ANXIETY SUCH AS:

- Racing heart?
- Avoiding certain situations?
- Difficulty making decisions?
- Generalized fear or dread?
